Our records indicate that we have not received a "Payer Request for Taxpayer Identification (W-9 form)." In order to comply with the IRS, this request is made to all individuals and business entities required to file an information return with the IRS and which are being paid through our Accounts Payable system.

Pursuant to section 3406(a)1A of the Internal Revenue Code, we are required to withhold 31% from all payments if a payee has not furnished his Taxpayer ID number or gives an incorrect Tax ID number. You have thirty (30) days from the date of this notice to submit your W-9; otherwise payments will be subject to backup withholding. If funds are withheld, they can only be refunded by the IRS. Be aware, if you are using your SOCIAL SECURITY NUMBER to file taxes, payments must be MADE and REPORTED under your name. We must have a legible signature on the form.

## **IMPORTANT TAX INFORMATION**

## Purpose of Form:

Use the form to report the taxpayer identification number (TIN) of the record owner of the account to the payer. Beginning January 1, 1984, payers must generally withhold 31% of taxable interest, dividend and certain other payments if you fail to furnish payers with the correct TIN (this is referred to as backup withholding). For individual taxpayers the TIN is the social security number. To prevent backup withholding on these payments, be sure to notify payers of the correct TIN. You must use this form to certify that the TIN you are giving to the payer is correct.

**Part 1** – How to Complete This Form – Give the payer the social security number or employer identification number of the record owner of the account. If the account belongs to you as an individual, give your social security number. If the account is in more than one name or is not in the name of the actual owner, consult the enclosed notice for additional guidelines on which number to report.

Part 2 – If you are not subject to backup withholding under the Internal Revenue Code Section 3406(a)(1)(C) you should check this box and certify under penalties of perjury your exemption. You are not subject to backup withholding if: (1) you have not been notified that you are subject to backup withholding as a result of failure to report all interest or dividends, or (2) the Internal Revenue Service has notified you that you are no longer subject to backup withholding.

**Part 3** – If a TIN has not been issued to you, but you have applied for a TIN or if you intend to apply for a TIN in the near future check this box under penalties of perjury. If you check the box in Part 3 and do not supply us with you TIN in 60 days, we will withhold 31% in all reportable payments thereafter until TIN and all certifications are supplies.
