







Accounting Transfer Pathway for College of San Mateo

Transferring Made Simple. The Transfer Pathways program eliminates the obstacles with the transition from the Community College to the Bachelor of Science (BS) in Accounting program at Notre Dame de Namur University (NDNU).

NDNU accepts transfer students for both spring and fall terms with any number of units. Our counselors and advisors will work with you to determine an individualized academic plan to map out and get you into the classes you need to graduate on time. Students can use this pathway document as a guide. Please keep in mind that not every prerequisite course needs to be completed prior to matriculation at NDNU. We will assist you to determine your individual needs.

Articulation Pathway toward a B.S. in Accounting

The following classes outline prerequisite courses taken at College of San Mateo, and specific upper division courses that must be taken at NDNU for the Accounting major. You will also find CSM courses that have been approved to satisfy the upper division content requirement of a course in the NDNU major. Please see the reverse side for more information and credit limitations.

General Education Requirements

You should plan to complete at least 28 units from the online Articulation Agreement between CSM and NDNU, including both required Cultural Diversity courses. The total number of units needed to fulfill all General Education and institutional requirements will vary depending on how requirements for foreign language and US History are met.

Students who have completed a full IGETC certificate may transfer without the need to take additional lower-division general education courses at NDNU; they will need to take additional upper-division general education courses (for example, Upper Division Writing, and Religious Studies, among others.) ^{**} The Community Engagement and Cultural Diversity requirements generally do not add units to your program. Rather, they are intended to be fulfilled by choosing courses from the approved list that also satisfy requirements in other areas of your program.
