## Application Requirements

- Professional resume and personal statement
- Official Transcripts (Proof of Bachelor's Degree)
- Two academic or professional letters of recommendation
- A cumulative grade point average of 2.5 or better 3
- Applicant must have a 4-year degree from an accredited university OR a 3-year degree from an accredited university with WES evaluation showing equivalency to a 4-year degree.
- Once admitted, meet with the Program Director
- Students must have taken the following undergraduate courses to be eligible for admission:
  - Financial or Managerial Accounting (3 units) or equiv
  - Microeconomics (3 units) or equiv
  - Macroeconomics (3 units) or equiv
  - Business Statistics (3 units) or equiv
  - Math for Business or Calculus I (3 units) or equiv
